The Wound Management Program at **Beth Abraham Health Services**, a 520-bed facility, located in the Bronx, New York, manages all types of wounds including pressure ulcers, venous, arterial and neuropathic ulcers as well as sub-acute burns.

Their multi-disciplinary team of physicians, physiatrists, dieticians, therapists, nurses and CNAs offer expert assessment and care identifying causative factors while supporting the patient's recovery both medically and nutritionally. The holistic approach combines a continuous focus on wound bed preparation and moist wound healing leading to successful outcomes for previously chronic and difficult to heal wounds.

Additional services include in-facility radiology, wound VAC, pressure mapping technology and vascular surgical consultations offering bedside arterial and venous flow studies.
